AND WHEREAS, the institution, MANOJ JAIN MEMORIAL COLLEGE, PLOT/KHASRA NO. 280/3A/1, 280/3B, 2/80/2B/2, VILLAGE-SHERGANJ, POST OFFICE: SATNA, TEHSIL/TALUKA: SHERGANJ, CITY: SATNA, DIST: SATNA485001, MADHYA PRADESH (**WRCAPP2967**) has by affidavit consented to come under New Regulations.

AND WHEREAS, on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit, and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee in its **245th** meeting held on **March 01 - 03, 2016** is satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the B.A. B.Ed. & B.Sc. B.Ed. Integrated Programme, such as, infrastructural and instructional facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

Integrated course of 4 (Four) years duration with an annual intake of **50 students (one basic unit of 50 students)** and B.Sc. B.Ed. Integrated Programme of 4 (Four) years duration with an annual intake of **50 students (one basic unit of 50 students)** from the academic session **2016-17**.

The institution shall gradually move towards becoming a composite institution as per clause 8(1) of the NCTE Regulations, 2014.

The institution shall comply with various other norms and standards prescribed in the NCTE regulations, as amended from time to time.



The institution shall submit to the Regional Committee a Self- Appraisal Report at the end, of each academic year along with annual statement of accounts duly audited by a Chartered Accountant.
